MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations from January 1, 2022 to June 30, 2022

Markets & Effect

The S&P/TSX Composite Index declined 9.9% during the first half of 2022 on a total return basis. All sectors, except energy and utilities, declined during the period. Notable detractors included information technology, financials and materials, which accounted for roughly half of the Index during this period.

Energy has been the best-performing sector since the beginning of the year. Sionna's fundamental view of the energy and select non-energy materials space is that supply is constrained and not likely to come back online in the immediate future. This is due to the capital discipline of oil and gas companies and the ongoing conflict in Ukraine.

The events in Ukraine initially sent commodity prices soaring, giving legs to the "higher inflation for longer" thesis. While the materials sector was a meaningful outperformer in the first quarter of 2022, it too suffered from pullbacks in nearly all materials prices on recession fears coming to light amidst the backdrop of high inflation and increasing interest rates. Canada's CPI rang in at 7.7% year-over-year in May of 2022, the highest level of inflation since the early 1990s, which has been driven by unprecedented monetary easing over the past two and a half years, as well as fractured supply chains and high energy and food prices. Some consumer staples and discretionary stocks are facing serious bouts of input cost inflation. For those companies without the pricing power to offset these rising costs, there will likely be margin compression, which implies lower levels of earnings than the market may be pricing in at this point.

The more defensive utilities sector was a relative outperformer as investors sought safety in companies with more durable business models typically found within these sectors.

Within the information technology sector, the less profitable, richly valued stocks led the decline, causing a growing bifurcation between these previously high-flying companies and the slower growth, highly profitable and

mature technology companies. After the recent decline in Canada's technology sector, the importance (and weight) of the sector relative to the overall Index, is now muted. This could provide some downside protection for the Index relative to other global developed markets if we continue to see weakness in the technology sector in this rising interest rate environment.

Rising inflation has forced a U-turn on accommodative monetary policy, thus fundamentally changing the view of lower-for-longer interest rates. For the first time in a long while, investors are having to think about what it means if interest rates moved higher, as opposed to the last decade when rates were expected to be stable or declining.

Performance

The Fund's Series A units outperformed its benchmark, losing 6.9% versus a loss of 12.4% for the Sionna Strategic Income Benchmark (the "Blended Benchmark"). (Please see the Benchmark Indices section for a full description).

The Fund returns are after the deduction of fees and expenses while the benchmark returns do not include any costs of investing. See the "Past Performance" section for the returns of the other series, which may vary because of differences in management fees and expenses or timing of series introduction.

Holdings in oil, gas & consumable fuels made a positive contribution to overall performance, while holdings in hotels, restaurants & leisure detracted from performance for the period.

Asset Mix

At June 30, 2022, 43.3% was invested in Canadian equities, 24.6% was in global equities, 29.3% was in fixed income, and approximately 2.8% was in cash and other net assets.

The Manager confirms that the Fund did not borrow money during the period.

Flows & Fees

The Fund's Net Asset Value decreased to \$96.7 million at June 30, 2022, from \$108.2 million at December 31, 2021. Of this change, a decrease of \$7.0 million was due to negative investment performance (net of investment income), and a decrease of \$4.5 million was due to net outflows.

For Series A units, the annualized management expense ratio ("MER") at June 30, 2022 is 2.29%, compared to 2.28% at December 31, 2021.

Recent Developments

There are no known changes at this time to the strategic positioning of the Fund, the manager, or portfolio sub-advisor.

The invasion of Ukraine by Russia on February 24, 2022 has resulted in western economic sanctions being imposed on Russia, notably barring Russian banks from the SWIFT financial messaging system, a key piece of banking infrastructure. In response to sanctions, Russian markets have been closed to all foreign investors. This has caused material volatility in Russian financial markets and impacted liquidity, market access and reliability of security prices. In addition, export embargoes may lead to increased volatility in commodity prices and global supply chain disruptions. It is uncertain how long the conflict, economic sanctions and market instability will continue and whether they will escalate further. The Fund manager and portfolio sub-advisor(s) continue to actively monitor the situation for any impacts on the Fund's existing as well as potential new holdings.

Effective April 22, 2022, Bridgehouse no longer pays trailing commissions to dealers that do not make a suitability determination, such as order-execution-only ("OEO") dealers, in accordance with the Canadian Securities Administrators' decision to end the payment of trailing commissions to OEO dealers that came into effect on June 1, 2022. Accounts held at OEO dealers are only permitted to purchase or hold securities of Series F of the Fund, which does not pay a trailing commission.

On April 22, 2022, all Series A units of the Fund held in accounts at OEO dealers were switched into Series F at no cost to the unitholder and without a disposition for tax purposes.

Effective June 1, 2022, Bridgehouse no longer offers purchases into the deferred sales charge ("DSC") series, including the low load series, of the Fund in accordance with the Canadian Securities Administrators' decision to ban all DSCs in Canada. Existing DSC redemption schedules for sales made prior to June 1, 2022 will be permitted to run their course.

The outbreak of the novel coronavirus, first detected in December 2019, rapidly became a pandemic and resulted in disruptions to the economies of many nations, individual

companies and the markets in general. This created closed borders, quarantines, supply chain disruptions and general anxiety, which negatively impacted global markets in an unforeseeable manner. The impact of the novel coronavirus and other such future infectious diseases in certain regions or countries may be greater or less due to the nature or level of their public health responses or due to other factors. Health crises caused by the coronavirus outbreak or future infectious diseases may exacerbate other pre-existing political, social and economic risks in certain countries. The impact of such health crises may be quick, severe and of unknowable duration. This pandemic and other epidemics and pandemics that may arise in the future could result in continued volatility in the financial markets and lead to increased levels of Fund redemptions, which could have a negative impact on the Funds and could adversely affect a Fund's performance.

Related Party Transactions

Manager and Portfolio Advisor

The Fund is managed and advised by Brandes Investment Partners & Co., operating as Bridgehouse Asset Managers ("Bridgehouse") which provides (or arranges for) investment management, distribution, marketing and promotion of the Fund. Bridgehouse receives a monthly management fee based on the daily average net assets of each series of the Fund. In addition, Bridgehouse is entitled to be reimbursed by the Fund for certain operating expenses.

Sionna Investment Managers Inc. ("Sionna") is the Fund's portfolio sub-advisor in respect of the Canadian Equity portion of the Fund and Brandes Investment Partners, LP ("Brandes LP") is the portfolio sub-advisor in respect of the non-Canadian portion of the Fund. Bridgehouse pays each of Sionna and Brandes LP an investment management fee to provide the Fund with investment management services. Bridgehouse and Brandes LP are affiliates.

Benchmark Indices

Sionna Strategic Income Benchmark: This blended benchmark is weighted 45% S&P/TSX Composite Index, 25% MSCI World Index, 20% FTSE Canada Universe Bond Index, and 10% Bloomberg Barclays U.S. Intermediate Credit Index (Hedged).

MSCI World Index: This index consists of equities from developed markets around the world, including Canada and the United States.

S&P/TSX Composite Index: This index tracks the performance of some of the largest and most widely held Canadian stocks listed on the Toronto Stock Exchange.

FTSE Canada Universe Bond Index: This index provides a broad measure of the total return for the Canadian bond market covering over 900 Canadian federal, provincial, municipal, and corporate bonds with maturities greater than one year and with a rating of BBB or higher.

Bloomberg Barclays U.S. Intermediate Credit Index (Hedged): This index measures the performance of investment grade corporate bonds in the United States with maturities of between one and ten years. The hedged version minimizes the exposure of currency fluctuations on index performance.

- The management expense ratio ("MER") is calculated as the total management fees and operating expenses paid by each series of the Fund, including GST/HST and interest and excluding commissions and other portfolio transaction costs, and the Portfolio's proportionate share of the MER, if applicable, of the Underlying Funds and Exchange Traded Funds in which the Portfolio has invested, allocated to that Series, and is expressed as a percentage of the average daily Net Asset Value of each series of the Fund on an annualized basis. Any management fee distributions paid by a series of the fund that effectively reduced management fees payable by some unitholders are not deducted from expenses to determine the overall MER of that series. The Manager, at its sole discretion, waives management fees or absorbs expenses. Such waivers and absorptions can be terminated at any time. The MERs of the Fund are shown both with and without the waiver and absorptions.
- Portfolio turnover rate is calculated at the Fund level based on the lesser of purchases or proceeds of sales of securities for the period, excluding cash, short term notes and bonds having maturity dates at acquisition of one year or less, divided by the average value of the portfolio securities for the period. The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.
- The trading expense ratio represents total commissions and other portfolio transaction costs, including the Portfolio's proportionate share of the commissions, if applicable, of the Underlying Funds and Exchange Traded Funds in which the Portfolio has invested, expressed as an annualized percentage of daily average Net Asset Value of the Fund. The trading expense ratio is calculated at the Fund level and applies to all series of the Fund.

MANAGEMENT FEES

Bridgehouse Asset Managers, the Manager, provides or arranges for investment management, distribution, marketing and promotion of the Fund. In consideration for the services provided, Bridgehouse Asset Managers receives a monthly management fee based on the daily average Net Asset Value of Series A and Series F. Management fees for Series I is negotiated and paid directly by the unitholders of Series I, and not by the Fund.

For the six months period ended June 30, 2022, the Fund paid Bridgehouse Asset Managers management fees of \$926,763. Bridgehouse uses these management fees to pay for commission payments to registered brokers and dealers and general investment management expenses. The breakdown (commission payments / investment management, administration and other) as a proportion of the management fee for each Series are:

- Series A (49% / 51%)
- Series F (0% / 100%)
- Series I (0% / 100%)

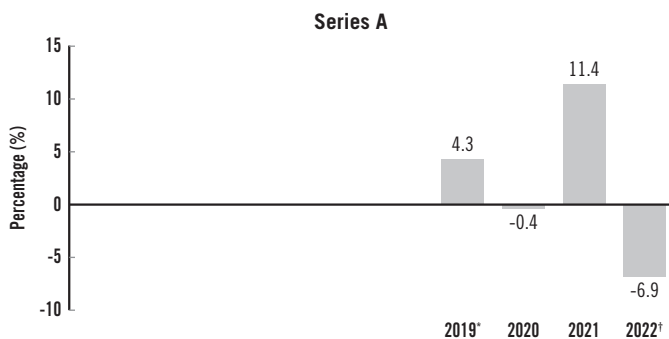
Commission payments represent cash commissions paid by Bridgehouse Asset Managers to registered brokers and dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by the Bridgehouse Asset Managers during the period. For new Funds or Series the amount presented may not be indicative of longer term operating periods.

PAST PERFORMANCE*

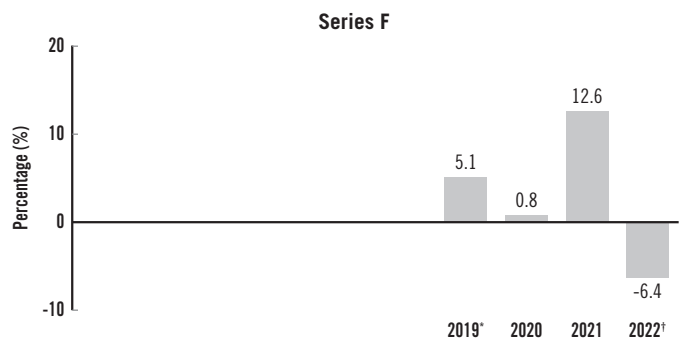

Management fees and operating expenses have been taken into account before calculating performance, except in the case of Series I units where the management fee is calculated outside of the Fund. Historical performance does not take into account the potential impact on returns of purchases, redemptions, distribution fees or other optional charges or income taxes payable by an investor. Keep in mind that past performance does not necessarily indicate how the Fund will perform in the future.

Year-by-Year Returns (%)

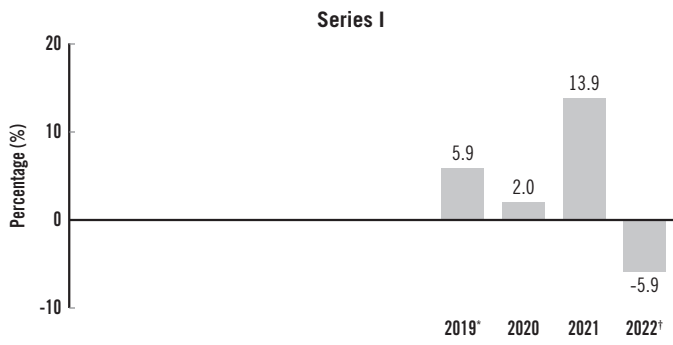

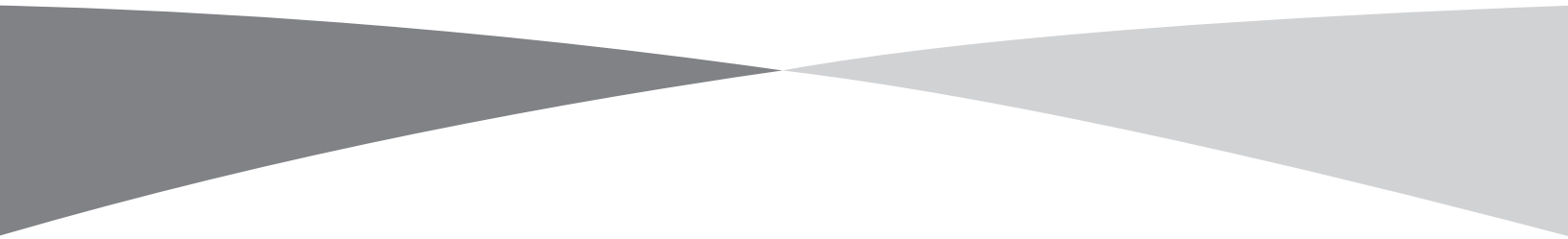
